Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations")- Intimation of Fire Incident

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we hereby inform that a fire incident occurred last night at the Company's unit located at Village Jeeda, Kotakpura Road, Bathinda – 151201. The fire broke out in the Company's godown used for the storage of raw cotton bales, which serve as raw material for the manufacturing process.

The reason of the fire is yet to be ascertained. The fire was promptly brought under control by the local Fire Department authorities along with the Company's internal team using inhouse firefighting systems. There have been no human casualties or injuries reported. The godown/ stock at the affected location is adequately insured, and the Company has already intimated the insurance company regarding the incident. An insurance survey is expected to be conducted in due course.
